

OnBoard Security User Evaluation License Agreement

IMPORTANT - READ BEFORE COPYING, INSTALLING OR USING

Do not copy, install or use the Materials (as defined below) provided under this limited license agreement (“Agreement”) from OnBoard Security (“OnBoard Security”), until you (“You”) have carefully read the following terms and conditions. By copying, installing or otherwise using the Materials, You agree to be bound by the terms of this Agreement. If You do not agree to the terms of this Agreement, do not copy, install, or use the Materials.

If You are agreeing to the terms and conditions of this Agreement on behalf of a company or other legal entity (“Legal Entity”), You represent and warrant that You have the legal authority to bind that Legal Entity to the Agreement, in which case, “You” or “Your” will mean such Legal Entity.

By agreeing to this Agreement, You affirm that You are of legal age (18 years old or older) to enter into this Agreement. If You are not of legal age You may not enter into this Agreement, and either Your parent, legal guardian or Legal Entity must agree to the terms and conditions of this Agreement and enter into this Agreement, in which case, “You” or “Your” will mean such parent, legal guardian, or Legal Entity.

Third Party Programs (as defined below), even if included with the distribution of the Materials, are governed by separate third party license terms, including without limitation, open source software license terms. Such third party license terms (and not this Agreement) govern Your use of the Third Party Programs, and OnBoard Security is not liable for the Third Party Programs.

1. LICENSE DEFINITIONS:

“Licensed Patent Claims” means the claims of OnBoard Security’s patents that are necessarily and directly infringed by use of the Materials to the extent authorized in Section 2 below, when the Materials are in its unmodified form as delivered by OnBoard Security to You and not modified or combined with anything else. Licensed Patent Claims are only those claims that OnBoard Security can license without paying, or getting the consent of, a third party.

“Development License Fee” is a fee of **TBD** for a one-year limited license which You must pay unless you destroy or return the Materials and all copies thereof at the end of the Trial Period.

“Development License Period” is the one-year license period covered by the Development License Fee.

“Materials” means Binary Code and End-User Documentation but do not include Third Party Programs.

“Binary Code” means Binary Code files pertaining to the TrustSentinel 2.0 software package that are provided pursuant to this Agreement and which may include interface or application code, and any updates, provided under this Agreement.

“Third Party Programs” (if any) are the third party software files that may be included with the Materials for the applicable software that include a separate third party license agreement in an attached text file.

“Trial Period” means the time period beginning from the date You receive Binary Code continuing for **45** calendar days, after which you must pay Development License Fee unless You destroy or return the Materials and any copies thereof.

“End-User Documentation” means textual materials intended for end users relating to the Materials.

2. LICENSE GRANT:

Subject to the terms and conditions of this Agreement, OnBoard Security grants You a time-limited (as set forth in Section 8), non-exclusive, worldwide, revocable, non-assignable, limited right and license:

A. under its copyrights, to:

- 1) Review the Binary Code, solely for internal use;
- 2) Make copies of or modify the Binary Code, but solely for internal use and only to the extent necessary to compile the Binary Code to function in a particular environment; and
- 3) Integrate the Binary Code into other software, solely for internal use.

B. Under its patents, to:

- 1) make copies of the Materials internally only;
- 2) use the Materials internally only; and

3) provided, further, that the license under the Licensed Patent Claims does not and will not apply to any modifications to, or derivative works of, the Materials.

3. LICENSE RESTRICTIONS:

Except as expressly provided in this Agreement, You may not:

- i. use, copy, distribute, transfer, or publicly display the Materials;
- ii. reverse-assemble, reverse-compile, or otherwise reverse-engineer any software provided solely in binary form,
- iii. rent or lease the Materials to any third party;
- iv. assign this Agreement;
- v. modify, adapt or translate the Materials in whole or in part;
- vi. distribute, sublicense or transfer the Materials or derivatives thereof to any third party;
- vii. include the Materials in malicious, deceptive, or unlawful programs or products; or
- viii. disclose the binary code or any implementation details thereof to any third party.

4. PAYMENT: The license granted under this Agreement terminates immediately at the end of the Trial Period unless you pay the Development Licensee Fee, which extends the license rights for one year from the date OnBoard Security receives your payment. All payments by You under this Agreement shall be made by wire transfer to the following bank account:

OnBoard Security may change the bank account to which payments are made from time to time by providing written notice to You of such change.

5. **OWNERSHIP:** Title to the Materials and all copies thereof remain with OnBoard Security. The Materials are copyrighted and are protected by United States copyright laws and international treaty provisions. You will not remove any copyright notice from the Materials. You agree to prevent unauthorized copying or distribution of the Materials. Except as expressly provided herein, OnBoard Security does not grant any express or implied right to you under OnBoard Security patents, copyrights, trademarks, or trade secret information.

6. **NO WARRANTY AND NO SUPPORT: THERE IS NO WARRANTY FOR THE MATERIALS, TO THE EXTENT PERMITTED BY APPLICABLE LAW. EXCEPT WHEN OTHERWISE STATED IN WRITING THE MATERIALS ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE MATERIALS IS WITH YOU. SHOULD THE MATERIALS PROVE DEFECTIVE, YOU ASSUME THE COST OF ALL NECESSARY SERVICING, REPAIR, OR CORRECTION.**

OnBoard Security may make changes to the Materials, or to items referenced therein, at any time without notice, but is not obligated to support, update, or provide training for the Materials.

7. **LIMITATION OF LIABILITY:** Neither OnBoard Security nor its suppliers shall be liable for any damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or other loss) arising out of the use of or inability to use the Materials, even if OnBoard Security has been advised of the possibility of such damages. Because some jurisdictions prohibit the exclusion or limitation of liability for consequential or incidental damages, the above limitation may not apply to You.

8. **TERM AND TERMINATION:** This Agreement commences upon Your receipt of the Materials and continues until terminated. Upon commencement, the license rights under Section 2 shall be granted for the Trial Period. You must then pay the Development License Fee, which will extend the license rights granted under Section 2 for one year from the date of receipt of payment (the "Development License Period"). If you elect not to pay the Development License Fee at the end of the Trial Period, this Agreement shall terminate immediately.

At the end of each one-year Development License Period, this Agreement may be extended for an additional one year period upon payment of an additional Development License Fee. If you elect not to pay the Development License Fee at the end of the Development License Period, this Agreement shall terminate immediately.

Either You or OnBoard Security may terminate this Agreement at any time upon 30 days prior written notice to the other party. OnBoard Security may terminate this license at any time if you are in breach of any of its terms and conditions. Upon termination for any reason, You will immediately destroy the Materials or return all copies of the Materials to OnBoard Security along with any copies You have made. Sections 1, 5, 6, 7, 8, 9, 10, 11, and 12 of this Agreement will survive termination.

9. APPLICABLE LAWS: All disputes arising out of or related to this Agreement, whether based on contract, tort, or any other legal or equitable theory, will in all respects be governed by, and construed and interpreted under, the laws of the United States of America and the Commonwealth of Massachusetts, without reference to conflict of laws principles. The parties agree that the United Nations Convention on Contracts for the International Sale of Goods (1980) is specifically excluded from and will not apply to this Agreement. All disputes arising out of or related to this Agreement, whether based on contract, tort, or any other legal or equitable theory, will be subject to the exclusive jurisdiction of the courts of the Commonwealth of Massachusetts or of the Federal courts sitting in that State, unless the parties mutually agree otherwise. Each party submits to the personal jurisdiction of those courts and waives all objections to that jurisdiction and venue for those disputes.

10. SEVERABILITY: The parties intend that if a court holds that any provision or part of this Agreement is invalid or unenforceable under applicable law, the court will modify the provision to the minimum extent necessary to make it valid and enforceable, or if it cannot be made valid and enforceable, the parties intend that the court will sever and delete the provision or part from this Agreement. Any change to or deletion of a provision or part of this Agreement under this Section will not affect the validity or enforceability of the remainder of this Agreement, which will continue in full force and effect.

11. EXPORT: The PRODUCT Software is eligible for (and is being exported under) License Exception ENC of the Export Administration Regulations under paragraph (b)(3) of 15 C.F.R. § 740.17 and OnBoard Security has submitted all notifications required to establish such eligibility. You must comply with all laws and regulations of the United States and other countries governing the export, re-export, import, transfer, distribution, use, and servicing of software. In particular, You must not: (a) sell or transfer software to a country subject to sanctions, or to any entity listed on a denial order published by the United States government or any other relevant government; or (b) use, sell, or transfer software for the

development, design, manufacture, or production of nuclear, missile, chemical or biological weapons, or for any other purpose prohibited by the United States government or other applicable government; without first obtaining all authorizations required by all applicable laws.

12. ENTIRE AGREEMENT: This Agreement contains the complete and exclusive agreement and understanding between the parties concerning the subject matter of this Agreement, and supersedes all prior and contemporaneous proposals, agreements, understanding, negotiations, representations, warranties, conditions, and communications, oral or written, between the parties relating to the same subject matter. No modification or amendment to this Agreement will be effective unless in writing and signed by authorized representatives of each party, and must specifically identify this Agreement.
